- d. Visit Wiltshire Membership membership of this organisation was taken out to highlight Tisbury and aid Tisbury Business Association; the cost in 2021 was £439 and Councillors at the time wanted to review this.
- e. Update on Play Area quotes and a suggestion for a Parkour facility updated costs for quotes from last year have been requested for the ends on the MUGA, but a 3rd is required; currently in region of £10 -12,000.
 - A suggestion has been made for a Parkour facility (as in Salisbury, but a smaller version) see promotional video.
 - An option for the long strip of tarmac on the King George Vth field is a series of fitness equipment but this is more adult orientated do Councillors have any views?
- f. Upgrade of current electrical wiring and additional wiring/sockets for the refurbished Youth Hub work for the replacement windows has now been ordered and updated quotes for the first fit electrical works are being requested. The wiring schedule and layout was prepared by Jake from Historic Buildings Advisory Service in the region of £5-6,000.

- a. Risk Register format revision an example is attached; the original information is presented in a different format but is largely unchanged. Changes made related to updates or items no longer relevant.
- b. BT Red Phone Box further update; a painting kit has now been delivered free of charge ...
- c. Court Street to Place Farm footpath this item is for information rather than to make any decisions. Councillors will remember the wooden slatted footpath that was installed early this year, but for which formal Highway approval was not sought; only that of the Planning Officer. On behalf of the Fonthill Estate, Mr Durnford is proposing to/ has submitted a revised proposal that is a longer route and may still not satisfy Highway requirements. However, Mr Durnford would like to engage with the Parish Council and gain potential support for any practical suggestions that can be put forward to satisfy the planning obligation

d. Advertising Boards at the Lower Recreation Ground – the Football Club is considering forms of sponsorship and suggestions have included attaching, say, 1m by 0.6m

boards on the inside of the boundary wall – no more than 10-12 ... similar to the ones

on the swimming pool.

If Councillors have no objections to this proposal, then maybe a proportion of any sponsorship could be allocated to the Bowls and Croquet Club? If so, this would I think need to be administered by the Council ...maybe?
