#### **Questions or Statements:**

Two members of the public spoke in support of their planning applications.

# 157.24 Planning and Tree Works Applications \*Clerk

PL/2024/11296 Land to the rear of Yattendon, Vicarage Road, Tisbury - Erection of 1 new dwelling, access, together with hard and soft landscaping, and associated works:

- Support subject to the following:
  - 1. A revision to the size of the triangular roof window for the purpose of reducing the degree of overlooking and extent of the loss of amenity to neighbouring properties.
  - 2. A condition whereby a 2 metre fence is required to be erected on the boundary with the Red House to reduce the extent of the loss of amenity.
- **JM/RAB**; with one abstention from FC.

**PL/2024/11003 Tisbury Post Office, High Street, Tisbury -** Replace all existing windows on 1<sup>st</sup> & 2nd floors and one to ground floor east elevation. Formation of new balustrade on top of existing brick parapet wall:

Support on the grounds that the application is compliant with Core Policy 57 of the Wiltshire Core Strategy; NE/FC; RB abstained.

PL/2024/11282 Paddock Wood, Hindon Lane, Tisbury - Change of use and conversion of two redundant rural buildings to a dwelling:

 The Council considered that the application contained insufficient information to take a decision. The application shows a calculation of 10% biodiversity net gain but then makes reference to the Emerging Local Plan which requires a level of 20% net gain.

PL/2024/11255 The Old Vicarage, Park Road, Tisbury - Conifer tree - Fell

 To leave the decision to the Tree Officer due to the applicant being a member of the Council; GM/RB.

**PL/2024/11617 The Elms, High Street, Tisbury -** Western Red Cedar tree - remove major limb to East and two limbs to South; cut back overhang from buildings & wall to ensure 30cm clearance; prune back crown extension to shape & crown lift to give 1.8m-2m clearance Bay tree- reduce height by 2m & cut back on North side to give 0.5m clearance from wall 1 x Weeping Willow tree & 2 x Lombardy Poplar trees – fell:

Support the works to the other trees but considered that the proposed work to the Western Red Cedar was too extensive for a tree of such prominence in the street scene. GM/JM; unanimous.
