

Tisbury Parish Council – Minutes of the Ordinary Meeting Held at 7.00 pm on Tuesday 4th February 2025 in the Reading Room, High Street, TISBURY, SP3 6LD

Questions or Statements:

A member of the public spoke in support of their planning application.

Councillor Reed moved to sit in the public section of the meeting room whilst the Council considered planning application PL/2025/00311 and spoke as a member of the public in objection to it. She rejoined the meeting after the Council had voted on the application.

Wiltshire Councillor Report: Councillor Richard Budden gave a detailed report on the following matters:

- The level of council tax to be charged in 2025/26 will rise by 4.5% in total. This comprises a general rise of 2.5%, plus a further 2% levy for Adult Social Care.
- Data provided to the Environment Select Committee for the first time has
 permitted analysis of the Council's expenditure on roads maintenance by road
 class and Community Area. The report focuses exclusively on non-principal
 roads: C-class and unclassified roads and sets out what monies have been
 spent and the differences in expenditure across the county's Community Areas.
- Over the four years from 2021 to 2025 there is considerable variation between Community Areas. Average spending on the total of all maintenance of nonprincipal roads ranges from less than £1,000 per kilometre per year in Marlborough to over 4 times as much in Salisbury. There may be specific project reasons for the relatively high expenditure in Salisbury, Trowbridge, Royal Wootton Basset and Cricklade (where expenditure ranged from 65% to 85% above the Wiltshire average).
- However, in contrast, total maintenance expenditure on non-principal roads in Westbury, Chippenham, Malmesbury, South West Wiltshire, Pewsey, Devizes and Marlborough was below the county average.

Councillor Budden said he would be asking for the Cabinet Member for Highways to attend the next Area Board meeting to enable councillors and residents to raise their concerns on the current condition of the roads in South West Wiltshire.

 - no dimensions are shown on the plans and the dormer window 'as built', and without permission, appears to be larger in scale than shown on the plans;
 - the dormer window 'as built' impacts on the amenity of the neighbouring properties and is dominant within the roofscape of that group of adjoined properties causing harm to the Tisbury Conservation Area;
 - no bat survey has been carried out;
 - the list of consultees does not include the Conservation Officer.

Tis the Season: Councillor Mason gave a report on the next Tis the Season event which was planned for Saturday 29th November 2025. In light of the poor weather in 2024 most of the event would be held inside using the Victoria and Hinton Halls between the hours of 10 am and 4 pm.

He also advised that the Carnival Committee had called an emergency meeting to determine whether the September event could go ahead in view of the small number of volunteers willing to help.

St John's Church: Councillor Coyle-Camp reported that the dedication service for the new East Window would be held on 9th February. On 8th February there would be a rare peal of bells heard from the church lasting several hours to celebrate the window which was to be performed by volunteer bell ringers.
