

# Tisbury Parish Council – Minutes of the Ordinary Meeting

Held at 7.00 pm on Tuesday 1<sup>st</sup> April 2025 in the Reading Room, High Street, TISBURY, SP3 6LD

#### **Questions or Statements:**

No questions or statements were received.

Wiltshire Councillor Report: Councillor Richard Budden gave his final report as a councillor before standing down at the forthcoming elections. He had looked back on a small number of individual cases where, by virtue of being the County Councillor, he had been able to make a difference. He said he was immensely grateful that the residents of Tisbury and its neighbouring parishes gave him the responsibility and opportunity to do so and added that he had been hugely impressed by the commitment and energy so many residents devote to community and voluntary activities - of an amazing variety - across all five parishes in the Tisbury Division.

He said the highlights of his work which had given him a level of satisfaction were:

- The challenging of Wiltshire Council on its policy regarding food waste, and to do so just before the government announced that in future all councils will be required to collect food waste separately.
- As a member of the Southern Planning Committee he had sought to support the building of affordable housing where possible while minimising inappropriate development.
- The evidence he flushed out that roads maintenance across the Tisbury Division has received less than its fair share of funding for many years. This also showed that this was true across the whole of the South West Wiltshire Community area. Spending on C-class and unclassified roads in the South Wiltshire area over four years was 80% higher than here, and in Salisbury and Trowbridge two and a half times as much. The charge of bias in previous spending was borne out when last year, out of 99 additional projects selected because they were the most urgent to be funded by an additional £22 million of council tax, 25% were in the South West, and 40% of those in the Donheads alone.

Councillor Budden commended the work and approach of Wiltshire Council officers on the whole. He also said he wished to highlight the support given and the work carried out by the Tisbury Parish Clerk who he thought was worth every penny the Council paid her.

# 208.24 Tisbury & West Tisbury Neighbourhood Plan - TisPlan 2

He said that at the end of the consultation Wiltshire Council would write a report to the Independent Examiner who, in turn, would issue his own report on the Plan. Subject to any changes he asked to be made to it, the process would then start for the Plan to be put to referendum.
