

Tisbury Parish Council – Minutes of the Ordinary Meeting Held at 7.00 pm on Tuesday 4th November 2025 in the Reading Room, High Street, TISBURY, SP3 6LD

Questions or Statements:

Two representatives of Serve On gave a detailed briefing and responded to questions from councillors on the organisation's purpose and the reasons it wishes to use the King George's Field and Youth Hub over the long weekend of 13th to 16th February 2026.

The Chairman of Tisbury Football Club spoke on the matter of the new Licence under negotiation with the Parish Council for use of the Lower Recreation Ground for another 10 years. He said that the Club accepted the proposed revised rent but asked that minor amendments be made to the Licence.

Report from Wiltshire Councillor Gerry Murray

Councillor Murray gave a detailed report on the following matters:

- 1. The Full Council meeting on 21st October lasted 12.5 hours with some but not all of the business being intentionally trivial and time-wasting. The key decisions taken were as follows:
 - The Council's plan was passed and is now the strategic plan of the Council.
 - Blue badges 3 hours of free parking was approved. This was a manifesto commitment for the Liberal Democrats.
 - The Wiltshire & Swindon Local Nature Recovery Strategy (LNRS) document was adopted and published. Councillor Murray recommended that councillors read it as, in his view, it was an amazing document. He advised that it had been developed in collaboration with Swindon Borough Council, New Forest National Park Authority, and Natural England as well as a wide range of stakeholders, including environmental groups, landowners and managers and ecological organisations. The Strategy will help meet the Council's biodiversity duty, support planning processes (including Biodiversity Net Gain). Importantly, the LNRS does not impose requirements on landowners or managers; instead, it encourages voluntary action through funding and investment opportunities. It will be a contextual document in planning decisions.
 - The Air Quality Supplementary Planning Regulation was approved and adopted. Air quality is about to become much more important in planning

- applications. For now, Wiltshire Council is updating and upgrading their standards and requirements for regulated areas.
- Tisbury Old Sports Centre site: A meeting is being arranged during November between the Leader of the Council, Councillor Ian Thorne, and representatives of Tisbury and West Tisbury Parish Councils and The Nadder Community Land Trust to consult on the future of the affordable housing project at this site.

Following concerns raised by Councillor Beattie that Wiltshire Council planning officers were not taking account of some of the Parish Council's views on planning applications, the Clerk agreed to write to the Southern Area Team Leader for Development Management to seek explanations for officers not taking account of the Council's comments.

161.25 Tisbury and West Tisbury Neighbourhood Plan

- **a.** Councillor Murray gave a short verbal report on the outcome of the Referendum:
 - The results were 486 (95.48%) people voted 'Yes', with 23 (4.52%) voting 'No' with a turnout of 22.28%.
 - He said that confirmation had been received from Wiltshire Council that the Neighbourhood Plan was now regarded as 'made' (adopted), subject to a 6 week challenge period. The document and its policies would now be taken into when planning applications were being determined.
 - It was one of only 5 re-adopted Neighbourhood Plans in Wiltshire.
 - Once the Wiltshire Local Plan had been adopted in mid-2026 parts of the Neighbourhood Plan would have to be revised. The key issue for both parish councils for the revision, and any future revisions, was that all

government funding had been withdrawn. Tisbury and West Tisbury parish councils therefore would have to consider in their upcoming budget discussions how they could raise the funds needed for future revisions.

- **b.** To consider his proposal that the Council's responses to all future planning applications makes reference to the Neighbourhood Plan:
 - **Approved; GM/JM;** unanimous. It was also agreed that a press release be issued on the results of the Referendum and that the Parish Council stall at Tis the Season 2025 will have a display of the results and information on the Plan.
